## Forty New Affordable Units to be Added to Highly Successful Murrieta Apartment Community

MURRIETA, Calif., Feb. 8, 2012 /PRNewswire/ -- On **Thursday, February 9, 2012 at 10:00 am**, Affirmed Housing Group will host a groundbreaking ceremony for phase II of Monte Vista Apartments. The architecture of Monte Vista II is designed to blend seamlessly with the existing development.
